More Dangerous Than Fear

Sometimes you really have to wonder. At a recent congressional hearing on governmental censorship of Americans, several of the witnesses invited to testify were openly attacked, vilified, and slandered in order to prevent them from relating their experiences of being censored. The slander was designed to disqualify the victims so that the slurs cast at them would make their testimony unworthy to be heard. Members of the federal government endeavored to silence victims of censorship in the name of claiming that the government does not censor. Wow. To do so on camera is even more amazing. The smarter thing to have done would be to feign compassion and understanding. 'Really, someone tried to silence you? In these United States? That's outrageous! We need to investigate this...' They'd no doubt fail to investigate but be on the record of opposing any violation of the First Amendment. The slanderers made it clear that freedom of speech is for some but not for others.

If freedom of speech is under the gun, one might ask about our other personal First Amendment rights such as freedom to free exercise of religion and the freedom of assembly. Surely these rights are not threatened, right? According to many elected and non-elected officials, any practicing Catholic nominated to be a federal judge is essentially disqualified on that basis alone. They happily discard the First Amendment for the sake of protecting a false right, abortion, nowhere to be found in the federal Constitution. So much for freedom of religion. During the recent pandemic, were our right to assemble peaceably and our right to exercise our religion respected? Not so much. For the sake of the 'common good' our rights were curtailed and our bishops remained largely silent. Indeed, there is no 'common good' clause in the Bill of Rights that allows the government to alienate our inalienable rights. The smarter thing to have done would be for the bishops to dispense the vulnerable and the fearful from their Sunday obligation but otherwise carry on. Instead, Christians chose to bow down before the 'common good' in favor of giving the Supreme Good His due.

Maybe the response during the pandemic was a well intentioned mistake or a panicked over reaction. Perhaps, but probably not. A recent movie has received harsh criticism and outright opposition largely because of its subject matter. This movie highlights the evils of the trafficking of children. Critics have claimed that this is a minuscule or even a non-existent problem. Hardly. Child trafficking is a significant problem today, perhaps more so than ever before. Some critics have dismissed this movie as being a product or a promotion of a specific reviled conspiracy theory. Oddly, UFOs have rapidly ceased to be the realm of tinfoil-hat-wearing conspiracy theorists but have become a reasonable and respected belief despite the fact that no decent, clear, or compelling photograph has even been taken of a UFO. Surely given the one billion continuously-filming surveillance cameras in operation and over forty billion personal cameras in use today, billions of which are within arm's reach at all times, one good, well-focused, and high-resolution snap of a flying saucer would exist. Zero UFO photos, yet there are an estimated 4 to 10 million children trafficked annually. One is a respectable belief, the other is a despicable conspiracy theory.

One would hope that our fundamental rights matter to everyone. If Fred's rights are infringed, what protects the rights of Barney, Wilma, and Betty? One would hope that the trafficking of children and all of the horrors that surround it would be an issue that all would condemn and diligently seek to eliminate from every country and culture of the world. It might happen to your daughter, your niece, your granddaughter, your neighbor's child or a complete stranger, but it should be, no it must be intolerable to anybody with a conscience and the slightest shred of human decency.

So, why do people turn a blind eye to the violation of people's God-given civil rights? Why in the world would anyone be indifferent to child trafficking, minimize its reality, or even deny that it exists? We might think it is fear since fear brings out odd and atypical behavior. The reality is that a different emotion is a work here: disgust. Disgust is more dangerous than fear. Why? We naturally avoid fearful things, but we strive to eliminate disgusting things.
