Many Thanks, Sisters!

We have been blessed by the presence of the Franciscans of the Poor of Jesus Christ since May of 2018. Bishop Baker invited the Poor of Jesus Christ to our diocese and asked that we put them up in the 'Little House' next to the rectory. The Little House, built in 1920 and last updated in the early 1970s, was in dire need of repair and renovation before the Franciscans could move in. Because the renovations were inexplicably behind schedule, their house was not ready in time for their arrival as promised. Thus Friar Gabriel and Friar Raphael, and a bit later Friar Leticio, had to live in the rectory on a temporary basis. They remained in the rectory until their house became minimally occupiable in October. Despite the housing debacle, they immediately began their ministry to the homeless of Birmingham and have continued in this endeavor ever since. In early 2020, the friars relocated to the old convent at Our Lady of Fatima, thus making the Little House available for sisters of the Poor of Jesus Christ. The sisters work with and share in the same ministry to the homeless as the friars.

With regard to the sisters, however, their time in Birmingham is coming to an end later this week. The sisters are having to curtail their outreach to the homeless not because there is no need, not because they found insufficient support from Blessed Sacrament and members of other parishes, not because they were unwelcome in the diocese or at Blessed Sacrament, not because they lack vocations, not because of any form of impropriety, and not because the sisters have chosen to leave for greener pastures. No, the problem lies in how our federal government has recently chosen to apply the rules for religious worker visas.

Given that the vast majority of the members of the Poor of Jesus Christ are from Brazil and other South American countries, they can only come here to do ministry under a temporary religious worker visa. They cannot use tourist visas, student visas, or temporary worker visas unless they come as tourists, students, or temporary skilled workers. If they were here on tourist, student, or temporary worker visas, they would violate the terms of their visas if they did religious ministry. If the diocese let them do ministry on the wrong type of visa, we would be in violation of the law. In other words, to do what the Poor of Jesus Christ do they could only be here, at least initially, on temporary religious worker visas. These visas have a duration of 30 months (two and a half years) and a second 30 month visa can be obtained allowing for 60 months of continuous presence and ministry in this country. However, at the end of that 60 month period, one of two things have to happen. Either the person holding the visa must return to their own country for at least a year before reapplying for another religious worker visa, or they could apply for a green card and remain here until the green card is granted or denied. Recently, the government has stopped accepting green card applications for temporary religious workers. What this means for the sisters is that once they have been here for 60 months, they must leave. Taking the option of applying for a green card away has disrupted the plans of the sisters (an other temporary religious workers) in a way that could not have been foreseen. This has also impacted the way the diocese obtains priests from India, Africa, and elsewhere.

Thus, the sisters faced a dilemma regarding the staffing of their various ministries throughout the country. They have communities in Kansas City, Birmingham, Los Angeles, Atlanta, and Baltimore all experiencing the same problem. In order to populate these communities with at least three sisters each, they must close one of them, sadly the one in Birmingham, for the sake of the others. It is not clear whether or not this might also happen to some of the other communities at a later date. For example, the friars are remaining in Birmingham, but given the way things are, that might or might not be sustainable from a visa standpoint.

Again, we have been greatly and thoroughly blessed by the presence and ministry of Sr Brisa, Sr Cecilia, Sr Clara, Sr Isabel, Sr Liz, Sr Luz, Sr Melanie, and Sr Miracles over the last three years. It is hoped that the immigration system will be fixed soon such that the sisters of the Poor of Jesus Christ might return and resume blessing us and the people of Birmingham.
