Is it Mortal?

So, we arrived at Mass late. Have we sinned? If so, would it be mortal or venial. To answer these questions, we need to ask what constitutes a sin, what makes a sin moral or venial, and whether or not we missed an important part of the Mass.

How do we define sin? What makes an act sinful? Three factors must be considered to determine whether or not we have sinned. The first and most obvious factor is the act itself or thing we did. Is the act legitimate for us or not? Some acts are permissible in and of themselves, such as reading, jogging, praying, working, eating, swimming, and so on. Some acts are only permissible for certain people, such as the marital act between a husband and his wife, but not permissible for people in different situations. Some acts are never permissible, acts we normally associate with wrongdoing or sin, such as blaspheming, coveting, lusting, stealing, defrauding, defaming, hating, idolatry, murdering, fornicating, and so on. Some acts in and of themselves that might be sinful but under certain conditions might not be accounted as sinful under other conditions. These acts are ones that require us to do something as opposed to requiring us to refrain from doing an act. We can always refrain from choosing idolatry or adultery, for example, but we cannot always obey someone in authority or pray as much as we ought. There is no situation where idolatry or adultery is unavoidable. But there are situations where we are unable to comply with a legitimate order; we are incapable of doing so or it is not reasonably possible to do. Carrying a piano by ourselves is an order we cannot fulfill because we lack the strength. Being ordered to feed and groom unicorns is impossible because unicorns don't exist. The Sunday Mass obligation requires us to do something that might be impossible to fulfill, such as when we are sick, when there is an ice storm or snow, when public Mass is not being offered (as in the covid shutdown), and so on.

Another factor in determining whether an act is sinful are the circumstances surrounding the act. One example would be doing something legitimate like reading or playing tennis when these are done such that we sinfully neglect serious responsibilities. For Mass attendance, sickness, weather, traffic, and other things normally out of our control are excusing circumstances. If we normally leave at 8:15 to arrive for the 9:00 Mass, leaving at that time would normally get us to church on time, but traffic or a stopped train might make us arrive late.

The third factor, besides the act itself and the circumstances surrounding the act, that must be considered as to whether we have sinned or not is the intention behind the act. If we pray – the act itself – and praying does not interfere with other pressing duties such as parenting or operating machinery that requires our full attention – circumstances – we can still sin by praying for something evil. Doing something legitimate that we know will be an occasion of sin for someone else is another example of a sinful intention.

Thus if the act itself, or if the various circumstances, or if the intention is evil, then the act is sinful. To put it another way, for an act to be good, the act itself must be good and the circumstances must be good and the intention must be good. Even acts that obviously seem good can be rendered sinful by circumstance or intention: donating a million dollars to a good and worthy charity thereby denying family members in dire need of financial assistance or doing so only for the sake of fame and notoriety. If the donation is made without neglecting other responsibilities and out of loving concern for others, then it is a good act.

Now, if the act itself or the circumstances or the intention renders an act sinful, how do we tell if it is a venial or a mortal sin? Again, three conditions must be considered. Was the sin serious, was it done deliberately, and was it done with sufficient knowledge. If all three conditions are met, it is a moral sin. If the sin was not serious or if it was not freely chosen or if it was done without full knowledge, it is a venial sin. In other words, the bar is low for an act to be venially sinful, but much higher for it to be a mortal sin.
