The Alabama IVF Controversy

Alabama has become the center of controversy regarding in-vitro fertilization (IVF). As usual, the media has twisted and distorted what truly happened. What people are hearing from the various media platforms is that Alabama has either banned IVF or passed a law declaring that human embryos are legally human beings. Of course, politicians are either scrambling to address the perceived issues or doing their level best to politicize this IVF controversy. It falls into the standard tropes of the so-called 'war on women' or the histrionics equating the issue with the dystopian book/movie 'The Handmaid's Tale.' Given that the 'Handmaid's Tale' is about forcing women into having babies, one must wonder how allegedly banning IVF somehow figures into the plot line of forcing women to have babies when supposedly outlawing IVF would do just the opposite.

So what really happened? In 2021 three couples sued a Mobile fertility clinic for having inadvertently destroyed their frozen embryos. The question faced by the Alabama Supreme Court was not whether or not the fertility clinic committed a crime, but to what degree they were responsible for punitive civil damages. In other words, was the destruction of these frozen embryos just a matter of property damage or is the fertility clinic liable for compensating these couples for wrongful death of the embryos. What the Supreme Court of Alabama ruled was that these embryos are to be regarded just like a baby in the womb for the sake of civil damages. It is not a huge logical or legal leap to conclude that a human life in-vitro (literally 'in glass') is indistinguishable from a human life in-utero ('in the uterus'). The Court thus ruled that 'the Wrongful Death of a Minor Act applies to all unborn children, regardless of their location.' The 1975 Wrongful Death of a Minor Act allows parents to seek punitive civil damages for the death of a minor child, including a pre-born baby. So, in the eyes of the Court, an unborn baby that dies because of trauma inflicted in an automobile accident is indistinguishable from an embryo killed through the negligence of a fertility clinic.

This ruling, however, does not change the law of Alabama nor does it outlaw IVF. The press picked up on the fact that several IVF clinics immediately ceased operations as proof of the procedure being outlawed when in reality the various clinics probably stopped doing procedures until they could figure out their potential exposure to financial risk. No doubt the fertility clinics carry insurance, but does that insurance cover potential wrongful death verdicts?

In any case, this is an opportunity to review the Church's teaching on matters of human life. Pope St Paul VI predicted in *Humanae Vitae* (1968) that the modern world's contraceptive mentality would result in four things: an increase in both sexual immorality and marital infidelity; the diminishment of the dignity of women even to the point of true objectification; governments resorting to draconian means to limit human fertility through contraception, sterilization, and abortion; and the use of technology to exert dominion over the human body and the creation of human life. Paul VI was widely mocked in 1968, but it would seem that he was totally correct on all counts.

It is that fourth prediction, that technology would be used to seek dominion over the creation of human life, that is the moral principal at stake when it comes to IVF and other fertility treatments. The Church affirms that married couples have a right to children, but like all rights, there are limitations to the exercise of that right. The right to conceive and bear children is limited to the natural, human, God-given means for procreation: technology is not a substitute to what God has ordained for human procreation. Thus, a child must be conceived of both husband and wife without recourse to the biological participation of third parties, it must be the result of a natural marital act between both husband and wife, and the child must develop in his own mother's womb. The role of technology cannot morally substitute for any aspect of the procreative process, but it is allowed to assist that process. In the case of IVF, where the baby may or may not be the offspring of both husband and wife, where the child is conceived outside of his mother, where the child can be born of a woman other than the wife, etc., there is little doubt that IVF represents a huge moral issue. - Fr Booth
